- 5. HB24-1149 C3E (merger of RREO and FRWD)

Randy: This is now at Senate Finance. We expect things to go well in Senate Finance. It will go to appropriations next before it goes to the full Senate floor.

One amendment said that one of the seats on the board needed to be a non-front range community. Transferring money from the current program to the new program.

6. SB24-123 Waste Tires

Randy: Out of appropriations this morning and will go to the House floor tomorrow. Administrative changes at this point. The more robust and grant for recycling tires is still in it.

## 7. HB24-1069 Vapes bill

Rachel: It is effectively dead. It was supposed to make a study for viable recycling options. We want to look at another route for a study. Maybe C3E. The other part is the battery working group. If you want to join the battery working group Rachel sent out an email.

## 8. HB24-1121 Electronic Equipment Right to Repair

This is going to the Governor's desk. This is the first bill of its kind in the country. We want to recognize the groups that took part in this achievement.
